The mission of **North Carolina Citizens for Constitutional Rights (NCC4CR)** is to challenge, through litigation, Governor Cooper's "Declaration of Public Health Emergency" and all subsequently issued executive orders and resulting actions.

The legal challenge is brought on behalf of all North Carolinians who have been injured in ways to numerous too fully list by way of unconstitutional Executive Orders and resulting actions in every county, city, and town in our State.

Those injuries include:

- Violations of our religious liberty
- Violations of our rights to free speech and assembly
- Violations of our right to free movement
- Violations of our right to education by means of school closures and unconscionable restrictions placed on the education of our children
- Deprivation of our life, liberty, and property without due process of law
- Businesses forced to close or limit operations so significantly that they had no choice but to shut down
- Job losses among the highest in the Nation, which denies our right to the "enjoyment of the fruits of [our] own labor"
- Mask mandates which may cause health problems
- "Social distancing" mandates that separated us from our loved ones, friends, and communities
- Restricted access to health care services, facilities, treatments, prophylaxis, and therapeutics
- Proliferation of alcoholism, drug abuse, violence, and suicide
- Cancellation of weddings, funerals, and ceremonies
- Sports and entertainment halted
- Threat of "mandated" vaccine and deprivation of liberty/rights if one does not consent to its administration
- "Living" in a constant state of fear, emotional anxiety, panic, depression, social isolation, loneliness, and despair

 - The lawsuit filing is urgent.
 - There is an urgency to file because Cooper is siding with medical tyranny.
 - Gov. Cooper & Mandy Cohen are making decisions that are destroying lives.
 - businesses pushing exempt people out of stores
 - medical facilities refusing care to the medically exempt
 - pharmacy's refusing to fill prescriptions if unmasked
 - schools forcing masks on healthy children all day & while playing sports
